- Cancellation of those three norms and rejecting the application of IO for Mr. Aykut İlker Mete

My concerns about the chairman of FIDE Events Committee is valid on this matter as well.

Mr. Aykut İlker Mete is a competent person for IO title, I may tell this since I know his skills and abilities. However, no one should be qualified for any title with false norm papers.

Hope you agree on this ethical principle.

I am sure Mr. Mete will understand this concern and very soon will be qualified in a correct procedure for this title.
